- Review measures to eliminate /reduce costs
- Usage of "WM Firewall" proper gates at 4 way assembly cells
  - 1. Containment within the plant 100% inspection by designated individual ID part with sticker or stamp
  - 2. Usage of new hire or current employee (union) to be discussed at plant level.
  - 3. Usage of daily tally sheet (for defects) to be filled out by inspector. Summarized weekly and to be used at plant level to identify issues to prevent problems.

John Little (see August 22, 2012 from John Little)

- Recent audit by regristrar BSI surveillance/re-certification audit focusing on
  - Production /control plans various regarding implementation of plans. Consider plans as dynamic and changing to be updated with QN or other quality issues. Preventative maintenance considered to be an issue with this area.
  - 2. Management review consideration of inputs and outputs. Metrics not meeting targets.
  - 3. Internal Audits not managed or followed or updated.

- EPP issues with Tegrant excessive flash and breaking
  - 1. QN to be issued
  - 2. Rob Purves to review
- G&R 4 Bill Wamboldt and Dave Fife
  - 3<sup>rd</sup> party sorting at all JCI Shelbyville, Warren and Kansas for P415 4 Way
    - 1. Rattle extra inspection 6000 parts inspected and 20 defective parts found. Root cause determined to be an oversized bushing. Permanent corrective action TBD.
      - 2. Inoperable Headrest no defective parts found by sorting company. Root cause determined to be date stamper had foreign material found in ball joint. Future change to an etching for the date stamping.

  - 1. Interim corrective action move assembly cell to the back.
